



## 2018 Loyal Sons & Daughters of Rutgers Award Nomination Form

### Evolution of the Award From the 1950's to Present

The Loyal Son of Rutgers Award was created in 1958 to recognize Rutgers Alumni Association (RAA) members for their leadership and service to their Alma Mater. As Rutgers grew and flourished through the decades, the Loyal Daughter designation was added to recognize the changing demographics and to honor the significant contributions made by women to the RAA.

The award criteria later expanded to recognize individuals who not only were volunteer leaders for their class and the RAA but had given extraordinary service to the broader Rutgers Community. Countless examples of extraordinary university service have ranged from serving on multiple governing boards, volunteering with numerous charter organizations including the legacy alumni groups and regional club as well as exemplary service within specific areas of the University for example, the band, glee club, the Court Club and the Touchdown Club. Other outstanding volunteers become creative ambassadors for the University in the community or bring long-standing skills in mentoring and networking. Rarely, employees of Rutgers have also been recognized for their service which is distinct and removed from their salaried duties, so as to maintain a broad distinction between voluntary service and professional work responsibility.

### Criteria for Loyal Sons & Daughters Award

The core criteria is that the volunteer service be substantial, sustained, and have significant impact for the University. The nomination should document the history of engagement as a volunteer, the results of the nominee's service and evidence of meaningful and beneficial service that resulted from the nominee's actions.

### Nomination Format and Content

To nominate a worthy individual, please complete this form. This form can also be completed online at <http://tinyurl.com/RULoyals>. (You may attach additional sheets for any section below.) The nomination should explain the nominee's worthiness of the award and highlight key aspects of his/her volunteer service that merits the selection committee's special consideration.

1. One and up to two collaborating letters of recommendation from individuals familiar with the background and volunteer service of the nominee.
2. Nominee's contact information to include name, address, phone numbers and email for the purposes of future contact if chosen.
3. Volunteer leadership, vision and relevance documenting the nominee's innovative approach to service or important and impactful results to the University, RAA, class, charter group, club, college, school, committee or board, or community outreach. Include specific examples and dates of volunteer service.
4. Impact and accomplishments of the nominee's skills and outcomes on the chosen volunteer service(s).
